Dear Agency Fee Payer:

Enclosed is our check representing the rebate of 2005-06 agency fees not related to collective bargaining and employment conditions.

As noted in our prior letter, the rebate percentages are:

NEA - 49 %
CTA - 34.5 %
LOCAL - 34.5 %

In addition, 100% of the temporary CTA \$60 dues increase for 2005-06, has been included in the rebate.

Interest at 2.86% has been added representing the interest earned to date on fees already received, which have been held in escrow. If you are in a category paying less than full fees, or if fees will not be collected for the entire year, the amount of refund will be the appropriate percentages of the fees actually paid.

If your contract calls for agency fees less than full NEA/CTA/Local dues, your rebate has been decreased by an amount equal to the reduction you have already received.

Should your status change to Active member, you will be asked to return a pro rata portion of your rebate.

Any questions you may have concerning the rebate should be referred to your local association.
